As a student, I have access to grants to attend University, whereas somebody who lives 5 miles away does not but still faces the same challenges of attending University from a rural background.

Living in rural Caithness is significantly more difficult and expensive already compared to living in town. Rural people have to live listening to the wind farms and dealing with the additional traffic and damage to the roads and landscapes, the people of Thurso and Wick do not. Please do not ring fence portions of this community benefit specifically for Wick and Thurso High Streets.

64	There is no such thing as a Communnity Benefit fund. It is simply a tiny carrot to persuade people that what you are doing is not as bad as it really is.
69	Cultural projects and events like galas and festivals
75	The third sector can offer solutions to many community issues but is not supported enough to do so. Funding organisations to deliver projects, employ project officers and development officers would make a considerable difference across the landscape. We need more recognition of what the third sector offers our communities - including the business community. When communities are a nicer place to live, work and visit, the spirit overall is better. Attracting people to move here is easier, empowering people to open shops in the high street is easier if people care about their towns and villages again. Singular projects without any consultation are much more likely to fail. Community organisations built on trust and run by local people who know the needs and wants of a community are far more likely to be successful. I'd love to see a significant fund available for a community hub, particularly in Thurso. This could be a space designed by those who will use it. It could include sports and leisure facilities, childcare provisions, cultural and social provisions, and a revenue provision to ensure continued operation. This kind of space would support many of the issues faced by those who live in Caithness & North Sutherland and reduce social isolation. Furthermore, a transport system to connect communities to the space so it's as inclusive as possible is essential. A Hub and transport system of this nature should be environmentally friendly and community owned/run.
77	Anything that addresses or curbs antisocial behaviour especially in young people. Perhaps the local police need your support? To do projects in and out of schools.
80	Lower energy bills to compensate for the glut of renewable projects in the county

One final thought, I apply often to the existing funds including those managed by the Chamber of Commerce. The Chamber is business focussed and no doubt does a great job of managing business funds. However as a community fund manager I feel I must tell you that they do not work well with community groups. I would recommend you decide how much you want to use annually towards business or economic purposes and let the Chamber do that, and decide how much you want to set aside for community groups and ask Foundation Scotland to step in and manage that bit.
